NOTICE OF PUBLIC HEARING

In the Matter of the Verified Petition of Jersey Central Power & Light Company Seeking Review and Approval of Its Deferred Balances Relating to, and an Adjustment of, the Societal Benefits Charge Clause of Its Filed Tariff ("2022/2023 SBC Filing")

PLEASE TAKE NOTICE that, on April 1, 2024, Jersey Central Power & Light Company ("JCP&L" or "Company") filed a Verified Petition with the New Jersey Board of Public Utilities ("Board") for the review and approval of the deferred balances accumulated with respect to the Demand Side Factor ("DSF"), Uncollectible Accounts Charge ("UNC"), and Nuclear Decommissioning Costs ("NDC") components of the Company's Societal Benefits Charge ("SBC"), to the extent accumulated for each from January 1, 2022 through December 31, 2023 ("Petition").

If approved, the proposed changes to the various components of the Rider SBC would result in an overall increase to the composite Rider SBC rate from \$0.006800 per kilowatt-hour ("kWh"), exclusive of Sales and Use Tax ("SUT"), to \$0.007026 per kWh, inclusive of SUT, and will result in an increase to the annualized monthly bill of a typical residential customer using 783 kilowatt-hours per month of \$0.18, or 0.15%, from a current bill of \$120.21 per month to \$120.39 per month based on the proposed Rider SBC and other rates effective as of April 1, 2024, including SUT. The proposed change in rates would become effective October 1, 2024 or on such date as the Board may determine.

The following illustrative chart shows the estimated monthly bill impacts, in both dollars and percentages, to class average customers based upon a comparison of present and proposed rates and the approximate net effect of the proposed increases in charges on customers in various rate classes. The total amount of the requested increase is \$4.203 million annually. The actual effect on specific customers will vary according to the applicable rate schedule and level of the customer's usage.
