The Tinton Falls Community Gardens (TFCG) provides an opportunity for residents to grow healthy fresh produce for their own use or for donations.

**2022 SEASON: November 15, 2021 – November 14, 2022**

**Open daily 8am to dusk**

**MEMBERSHIP RESPONSIBILITIES AND RULES:**

1. I will plant only in my assigned plot and ensure my plants do not overgrow and extend into the aisles. **My bed will be planted and kept weed free throughout the growing season. “Weeding” applies to the areas around my plot on all sides. All diseased or pest infested plants must be removed immediately or will be removed by the Garden Leadership Committee.**
2. I will not plant invasive species of plants or those with spreading runners. (A few examples are bamboo, mint, Jerusalem Artichoke, etc.)
3. Plants and plant structures should not shade a neighboring garden. Be aware of the sun’s daily cycle when deciding what and where to put your plants.
4. If my plot and/or surrounding walkways become overgrown with weeds, I understand I will be given 1 week’s notice to clean it up; failure to do so may result in forfeiture of my plot. I will ensure my plot is cared for in my temporary absence (example: vacation) and will notify the TFCG Chairperson of my arrangements.
5. I am responsible for watering my own plot. I will not leave a hose running unattended. I will turn off all water spigots after use and coil all hoses neatly on the posts provided. I will not drag hoses through someone else’s garden plot.
6. I will pick only my own crops (unless given permission by another plot’s owner). I will be respectful of the personal space of other gardeners and will not harm, interfere with, or remove tools and other items from other gardener’s plots.
7. I will make sure that all garden gates are closed and securely in place while working in the gardens. When I leave, I will make sure no one is in the garden before I securely close the latch at the top of the gate and replace the carabiner on the outside of the gate.
8. I will clean and return all TFCG tools to their designated area after use. I will transfer all garden waste to designated compost bins/areas.
9. I will remove trash from my plot and adjacent pathways and fences. At the end of the season and the closing of my plot, I will remove all plant material (including weeds) and bring the plot back to its original state.
10. I will participate in TFCG “work days” that are scheduled. (Ex: Spring/Fall cleanup/mulching of gardens.)
11. I will NOT bring pets to the garden. Any children that accompany me must always be supervised by an adult . Visitors within the garden areas must always be escorted by a TFCG member .
12. I will only use certified organic products in my plot. (OMRI products are preferred. [www.omri.org](http://www.omri.org).)
13. I will NOT consume alcoholic beverages or smoke on the Community Garden property.
14. If I must abandon my plot for any reason, I will notify the Garden leader.

## TFCG PROVIDES:

- Water spigots and hoses at designated locations inside the garden.
- Protective fencing around the Community Garden.
- Compost bins and/or areas for disposal of garden waste.
- General soil preparation, garden layout and coordination prior to and throughout the garden season.
- Access to a Master Gardener for questions and suggestions during the garden season
- Periodic communication updates via email.

Please designate on your application which plot size you're requesting and enclose it with the corresponding fee as directed above.

All plots are 4' wide; lengths vary as indicated below:

- Tinton Ave garden (TFCG-1): Small: 10', 11', or 13' long (\$20 per plot)  
Large: 20', or 23' long (\$25 per plot)
- Water Street garden (TFCG-2): Large: 16' long (\$25 per plot)

Once reviewed and approved by the TFCG Committee, participants will be notified of their plot number assignment(s). Original form will be held by the TFCG Committee.

### Additional Notes:

- Members are assigned individual plots to grow and harvest their produce. They decide if they want to consume it themselves or share it with other people or organizations.
- The number of plots per gardener may be limited depending on demand. All participants must be 18 years or older to have a plot at the Tinton Falls Community Gardens.
- Plots are assigned annually on a first-come, first-served basis. If no plots are available, the Garden Committee will keep a waiting list and will notify interested parties as space becomes available.
- If the plot size or location you requested is not available, we will contact you to discuss other options. Most new gardeners will likely be assigned to the Water Street garden.
- Returning Gardeners: You must specify on your application if you want the same plots as the prior year. Failure to do so may result in assignment of the plots to another gardener.
